## **G-3 TECHNICAL DIRECTION MEMORANDUM (TDM)**

- (a) For the purposes of this clause, technical direction includes the following:
- (1) Direction to the Contractor which shifts work emphasis between work areas or tasks, requires pursuit of certain lines of inquiry, fills in details or otherwise describes work which will accomplish the objectives described in the statement of work;

- (d) A TDM shall be considered issued when the Government deposits it in the mail, or if transmitted by other means, when it is physically delivered to the contractor.

When, in the opinion of the Contractor, any technical direction calls for effort outside the scope of the contract or inconsistent with this special provision, the Contractor shall notify the Contracting Officer in writing within ten (10) working days after its receipt.

- (a) The Contractor agrees to assign to the contract tasks those persons whose resumes were submitted with its proposal and who are necessary to fulfill the requirements of the contract as "key personnel". No substitutions may be made except in accordance with this clause.
- (b) The Contractor understands that during the first ninety (90) days of the contract performance period, no personnel substitutions will be permitted unless these substitutions are unavoidable because of the incumbent's sudden illness, death or termination of employment. In any of these events, the Contractor shall promptly notify the Contracting Officer and provide the information described in paragraph (c) below. After the initial ninety (90) day period the Contractor must submit to the Contracting Officer all proposed substitutions, in writing, at least fifteen (15) days in advance (thirty (30) days if security clearance must be obtained) of any proposed substitution and provide the information required by paragraph (c) below.
- (c) Any request for substitution must include a detailed explanation of the circumstances necessitating the proposed substitution, a resume for the proposed substitute, and any other information requested by the Contracting Officer. Any proposed substitute must have qualifications equal to or superior to the qualifications of the incumbent. The Contracting Officer or his/her authorized representative will evaluate such requests and promptly notify the Contractor of his/her approval or disapproval thereof.

**H-3 ONR 5252.216-9706 - LEVEL OF EFFORT (DEC 88)**

- (a) The Contractor agrees to provide the total level of effort specified in the next sentence in performance of the work described in this contract. The total level of effort for performance of this contract shall be 28,800 total hours of direct labor for the basic award, and approximately 28,800 total hours for each option, if exercised, including subcontractor direct labor for those subcontractors specifically identified in the Contractor's proposal as having hours included in the proposed level of effort. A breakdown of labor categories and hours is set forth in paragraph (k) below.
- (b) The level of effort for this contract shall be expended at an average rate of 2400 hours per month for the basic award and approximately 2400 hours per month for each option, if exercised. It is understood and agreed that the rate of hours per month may fluctuate in pursuit of the technical objective, provided such fluctuation does not result in the use of the total hours of effort prior to the expiration of the term of the contract.
- (c) The Contractor is required to notify the Contracting Officer when any of the following situations occur, or are anticipated to occur: If during any three consecutive months the monthly average is exceeded by 25% or, if at any time it is forecast that during the last three months of the contract less than 50% of the monthly average will be used during any given month; or, when 85% of the total level of effort has been expended.
- (d) If, during the term of the contract, the Contractor finds it necessary to accelerate the expenditure of direct labor to such an extent that the total hours of effort specified would be used prior to the expiration of the term, the Contractor shall notify the Contracting Officer in writing, setting forth the acceleration required, the probable benefits which would result, and an offer to undertake the acceleration at no increase in the estimated cost or fixed fee together with an offer setting forth a proposed level of effort, cost breakdown, and proposed fixed fee for continuation of the work until expiration of the term hereof. The offer shall provide that the work proposed will be subject to the terms and conditions of this contract and any additions or changes required by then current law, regulations, or directives, and that the offer, with a written notice of acceptance by the Contracting Officer, shall constitute a binding contract. The Contractor shall not accelerate any effort until receipt of such written approval by the Contracting Officer. Any agreement to accelerate will be formalized by contract modification.
- (e) The Contracting Officer may, by written order, direct the Contractor to accelerate the expenditure of direct labor such that the total hours of effort specified in paragraph (a) above would be used prior to the expiration of the term. This order shall specify the acceleration required and the resulting revised term. The Contractor shall acknowledge this order within five days of receipt.
- (f) If the total level of effort specified in paragraph (a) above is not provided by the Contractor during the term of this contract, the Contracting Officer shall either (i) reduce the fixed fee of this contract as follows:

- (g) In the event the government fails to fully fund the contract in a timely manner, the term of the contract may be extended accordingly with no change to cost or fee. If the government fails to fully fund the contract, the fee will be adjusted in direct proportion to that effort which was performed.
- (h) Notwithstanding any of the provisions in the above paragraphs, the Contractor may furnish hours up to five percent in excess of the total hours specified in paragraph (a) above, provided that

the additional effort is furnished within the term hereof, and provided further that no increase in the estimated cost or fixed fee is required, and no adjustment in the fixed fee shall be made provided that the Contractor has delivered at least 95% of the level of effort required in paragraph (a) above.

of Electronic Warfare Programs**

## 1.0 INTRODUCTION

The Tactical Electronic Warfare Division of the Naval Research Laboratory (NRL) is engaged in a variety of research and development activities in Electronic Warfare (EW), Command, Control, Communications, Computers and Intelligence (C4I) software development, C4I embedded training, IR simulator systems and training range system development.

## 2.0 SCOPE

The contractor shall conduct research, analysis and computer programming in the development of software services with the Defense Information Infrastructure Common Environment (DII COE) and the development of C4I mission applications within various DII COE compliant C4I systems such as the Global Command and Control System (GCCS), GCCS-Marine, Global Combat Support System (GCSS) and Integrated Intelligence and Imagery (I3) system. Details of the tasks are contained in Section 3.

## 3.0 TASK DESCRIPTION

The tasks shall be performed primarily at NRL with data collection and system integration and evaluation tasks taking place at remote sites (e.g., Key West, Florida; Norfolk, Virginia; and San Diego, California) and aboard Navy ships.

### 3.1 Task 1 - C4I Segment Maintenance

The contractor shall perform analysis, computer programming design and coding, data base design, software testing and system documentation for design upgrades to the following components of the DII COE compliant C4I systems: Embedded Training, the Run Time Infrastructure (RTI) Segment, the C4I Ambassador, Reconstruction Segment and the Large Area Track Range (LATR) Segment. These segments are currently

operational or being prepared for release. These command and control software components comprised of sets of algorithms, decision aids, graphics, data management and communications programs designed to support operational forces to train hostile engagements, conduct warfare, control military exercises and to perform assessments following operations. The contractor shall support the operational testing and military introduction of new releases of these components.

### 3.2 Task II - Embedded Training Software Development

The contractor shall develop embedded training software and techniques for the insertion of single operator and team training into modern command and control systems. These designs include the development of web based techniques embedded within host C2 systems (e.g., GCCS, GCCS-M, GCSS and I3) and their interaction with external training systems including the Battle Force Tactical Trainer (BFTT) and the Joint Simulation System (JSIMS) as well as war-gaming and other types of simulations that support team training. The development shall include software programs, embedded in GCCS, etc., that generate scenarios, control scenarios within the host C2 system, create training network servers, create training sessions and run training sessions. The primary focus of this work is the development of training software with a small amount of courseware content development.

### 3.3 Task III - Navy Electronic Warfare Segment Developments and the Specific Emitter Identification System

The contractor shall develop techniques and procedures for applying computer concepts and technologies to aid the real time control of EW actions across a battle space in offensive and defensive roles. This effort shall include translation of fleet and military operational requirements into decision support specifications, conceptualization and design of decision aids for data fusion; employment, planning and control of decoys, chaff, jamming and operations deception devices; and integration of command and control decision aiding for hard kill and soft kill employment. These decision aids will include the optimization of employment of EW assets and their integration with hard kill actions. The contractor shall design and code these EW command and control concepts at the Naval Research Laboratory and install and test them at other government facilities and commands including the Space and Naval Warfare Systems Center, Fleet Information Warfare Center (FIWC), Fleet Tactical Training Group (FLTACTRAGRU), and aboard Navy ships.

### 3.4 Task IV - C4I Interoperability and Embedded Simulations

The contractor shall develop interoperability methods and software to link C4I systems to external simulations such as training systems and to internal simulation based tactical mission applications such as course of action (COA) analysis, scenario based planning and embedded training simulations. This effort shall include integration of the High Level Architecture Runtime Infrastructure (HLA RTI) with the DII COE services and C4I Mission Applications, developing HLA Federation/Simulation Object Models (FOM/SOM) optimized for C4I and continued development of the C4I Ambassador Segment that manages internal C4I distribution and management of simulated data. This task will include the modification and integration of simulations as Segments within C4I systems such as the development of a Course of Action Analysis Segment within GCCS-M based on algorithms and software contained within the Naval Simulation System (NSS).

### 3.5 Task V - IR Seeker Simulation Hardware and Algorithms

The contractor shall provide engineering and technical support to continuing activities involving upgrades to the IR simulator systems including the Foxtrot and Victor simulator that enhance the simulators overall effectiveness and accuracy. The contractor shall provide support for the evolution of Foxtrot and Victor by modifying the software and hardware systems to produce smooth tracking performance when installed on the NRL P3 aircraft. Gimbals stabilization must be achieved with an upgrade from the current custom bus design to a standard VME bus based system for both of these simulators. Planned enhancements include hardware/software updates and construction of a compact Foxtrot suitable for operation in a lab or at the Chesapeake Bay Detachment (CBD) in parallel with a new smaller flight configured Foxtrot installed in a Standard Instrument Pod (SIP) on the NRL P3 aircraft. Algorithm extensions will center on the development of real time image understanding capabilities permitting identification and separation of targets, clutter, background and decoys. Hardware features along with the appropriate software drivers will be added to the system automatic interpretation of the real time image sequences collected by both Foxtrot and Victor.

The contractor shall perform field and laboratory measurements of countermeasure systems employing the hardware simulators installed at the NRL Chesapeake Bay Detachment, other shore sites or on the NRL P3 aircraft. The contractor shall collect video and digital data of decoys, ships and background with existing data collection equipment. The contractor shall add voice annotation for real time reporting of test progress and decoy performance.


