STATEMENT OF WORK

Engine and Starter / Generator Development for the Air Launched Integrated Countermeasure, Expendable (ALICE)

1.0 Background

The Naval Research Laboratory (NRL) has a requirement for an engine and starter / generator for the ALICE project. ALICE is an unmanned aerial vehicle (UAV) which is air launched from an F/A-18 at speeds up to 1.2 M. After launch, the UAV will glide and decelerate to a speed of approximately 165 kt at which point the engine starts and a cruise wing deploys. The UAV will be able to cruise up to one hour before deploying the loiter wing and operating at a speed of approximately 65 kt. During the cruise phase, most of the 20 hp engine power will be used to power the propeller (approximately 75 percent); during the loiter phase, the engine power will be lower and divided almost equally between the propeller and the starter / generator.

The engine and starter / generator system should fit into an eleven inch tube and be as short in length as possible. As always in an aircraft, weight needs to be kept at a minimum for all components. The engine will drive the variable pitch propeller that is currently being designed by NRL and it will also drive the starter / generator. The starter / generator will start the engine after the aircraft is released from the F/A-18 and produce all of the electrical power during operation for both the aircraft and the payload. In the future, the engine and starter / generator shall be incorporated into the aircraft for autonomous operation.

2.0 Scope

The Contractor shall develop and provide an engine and starter / generator prototype that incorporates the requirements developed by NRL. The Contractor shall provide drawings, schematics, test data, and operational procedures.

3.0 Engine and Starter / Generator Requirements

3.1 Engine Requirements

- a) The engine shall start with greater than 90 percent reliability at a density altitude of up to 15,000 feet after a 4-hour cold soak at temperatures between -50 and -55 degrees F. The current design concept allows for an air start.
- b) The engine shall use heavy fuel exclusively, i.e. JP-5 and/or JP-8, with a specific fuel consumption (SFC) of less than 1.25 lb/hp/hr at 20 hp in an

operational configuration, i.e. with starter / generator, muffling, pre-heater, and / or any other necessary system components.

- c) The maximum engine output shall be 20 hp +/- 10 percent with the final drive rotating at 8000 rpm. Reduction gear is allowed but not required. This engine power includes the power required to drive the starter / generator.
- d) The target engine size including the starter / generator is less than 11 inches in diameter, i.e. it shall fit into an 11 inch tube. Length should be as short as reasonably possible.
- e) The total weight of the engine system (without the starter / generator) shall be less than 1.25 lb/hp. The engine system includes any muffler, pre-heater, and other necessary components.
- f) The engine shall be able to drive a front mounted, clockwise rotating variable pitch propeller mounted along the centerline of the aircraft and also be connected to the starter / generator.

3.2 Starter / Generator Requirements

- a) The starter / generator shall be able to start the heavy fuel engine with 90 percent reliability at 10,000 to 15,000 feet density altitude after a 4 hour cold soak at temperatures between -50 and -55 degrees F. The current design concept allows for an air start.
- b) The starter / generator shall produce at least 2.25 kW while being driven by the engine over the power range of 10 to 20 hp including the power to drive the propeller.
- c) The total efficiency of the starter / generator shall be at least 80 percent.
- d) The target starter / generator size including the engine is less than 11 inches in diameter, i.e. it must fit into an 11 inch tube. Length should be as short as reasonably possible.
- e) The starter / generator weight including any system components, e.g. batteries, shall be less than 3 lbs.

4.0 Program Design Review

The contractor shall present the engine and starter / generator designs to NRL for approval prior to beginning fabrication.

5.0 Testing

The contractor shall provide engine and starter / generator testing data to verify performance of prototype engine and starter / generator prior to delivery.

6.0 Deliverables

6.1 Monthly Progress Reports

Deliverables shall include monthly letter-format progress reports.

6.2 Final Report (Rough Draft)

A rough draft of the final report shall be delivered at the completion of the contract. The rough draft shall be edited by NRL and returned to the contractor with specific requests for additional information to be added to the report as necessary. The delivery of the final report and any hardware shall be within 18 months after award of contract.

6.3 Final Report

A final report shall be written by the contractor from the edited rough draft and delivered to NRL within 30 days of receiving the edited rough draft.

6.4 Hardware Deliverables

A prototype engine and starter / generator meeting the specifications identified in section 3.0 shall be delivered to NRL upon completion of the contract.
