Description

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in Federal Acquisition Regulations (FAR) Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; proposals are being requested and a written solicitation will not be issued. The solicitation, N00173-04-R-KK07, is issued as a Request for Proposal (RFP). The solicitation document and incorporated provisions and clauses are those in effect through FAC 2001-24 and DFARS Change Notice 20040625. The associated small business size standard is 500 employees. NRL has a requirement for a thermal analysis system, which is to include a modulated differential scanning calorimeter, a thermogravimetric analyzer, along with requisite hardware and software to control the system, an accessory to enable sample cooling below room temperature, and a software upgrade to an existing ARES mechanical spectrometer. Delivery and acceptance is at NRL, Washington, D.C. 20375 FOB Destination. Delivery shall be no later than 30 days from date of award. The provision at 52.212-1, Instructions to Offerors-Commercial, applies to this acquisition

The Government intends to award a contract resulting from this solicitation to that responsible offeror proposing the lowest price for the items that have been determined to comply with the requirements of the specifications and solicitation. The proposal must demonstrate an understanding of the requirement and the ability to meet the specifications.
