Description

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in Federal Acquisition Regulations (FAR) Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; proposals are being requested and a written solicitation will not be issued. The solicitation, N00173-05-R-SK01, is issued as a Request for Proposal (RFP). The solicitation document and incorporated provisions and clauses are those in effect through FAC 2001-27 and DFARS Change Notice 20050113. The associated small business size standard is 500. NRL has a requirement for a Three-Dimensional Serial Sectioning System to include a metallographic optical microscope and digital microscopy camera. Delivery and acceptance is at NRL, Washington, D.C.20375, FOB Destination. Delivery shall be no later than 60 days after date of award. The provision at 52.212-1, Instructions to Offerors-Commercial, applies to this acquisition. The provision

at FAR 52.212-2, Evaluation--Commercial Items is incorporated. The Government intends to award a contract resulting from this solicitation to that responsible offeror whose offer conforming to the solicitation will be the most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate the offers such as technical capability of the item offered to meet the Government requirement, price, and past performance. The technical factors are more important than cost and all factors are listed in descending order of importance. Offeror must complete and submit with its proposal, FAR 52.212-3 Offeror Representations and Certifications--Commercial Items and DFARs 252.212-7000 Offeror Representations and Certifications--Commercial Items, which are identified as B and available electronically at: <http://heron.nrl.navy.mil/contracts/repandcerts.htm>. The clause at FAR 52.212-4, Contract Terms and Conditions--Commercial Items and FAR 52.212-5, Contract Terms and Conditions Required To Implement Statutes or Executive Orders--Commercial Items, applies to this acquisition. The additional clauses cited within this clause are applicable: 52.203-6, 52.219-4, 52.219-8, 52.222-3, 52.222-19, 52.222-21, 52.222-26, 52.222-35, 52.222-36, 52.222-37, 52.222-39, 52.225-13, and 52.232-33. The DFARs clause at 252.212-7001, Contract Terms and Conditions Required to Implement Statutes or Executive Orders Applicable to Defense Acquisitions of Commercial Items applies to this acquisition. The following additional DFARs clauses apply: 252.204-7004.

The following additional FAR clause applies: 52.215-5. Facsimile proposals are authorized. In addition proposals may be transmitted by email to susan.kelly@nrl.navy.mil (primary) or jan.bays@nrl.navy.mil (alternate) in either Microsoft Word (2000 or earlier) or PDF format. Only one copy is required when utilizing facsimile proposals. A complete original signed offer may be requested. All EIT supplies and services provided under any resultant contract must comply with the applicable accessibility standards issued by the Architectural and Transportation Barriers Compliance Board at 36 CFR part 1194 (see FAR Subpart 39.2). Electronic and information technology (EIT) is defined at FAR 2.101. Any resultant contract will be DO Rated under the Defense Priorities and Allocations System (DPAS). All responsible sources may submit a bid, proposal, or quotation, which shall be considered by the agency. The Contract Specialist must receive any questions no later than 10 calendar days before the response date of this solicitation. The package should be marked with the solicitation number, due date and time.
