### Description

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in Federal Acquisition Regulations (FAR) Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; proposals are being requested and a written solicitation will not be issued. The solicitation, N00173-06-R-CB03, is issued as a Request for Proposal (RFP). The solicitation document and incorporated provisions and clauses are those in effect through FAC 2005-09 and DFARS Change Notice 2006041. The associated small business size standard is 334418 and number of employees 500. NRL has a requirement for Contract Line Item Number (CLINS) as follows: CLIN 0001 ? The contractor shall provide a OTN/SONET/SDH Network Tester System in accordance with Attachment No. 1 for a quantity of one (1) LO. CLIN 0002 ? Data in accordance with the Contract Data Requirements List, DD 1423. Delivery and acceptance is at NRL, Washington, D.C. 20375,

FOB Destination. Delivery shall be no later than 90 days from date of award. Inspection and Acceptance of the OTN/SONET/SDH Network Tester System will be accomplished by the Technical Manager 7 days after receipt of the system. All responsible sources may submit a proposal which shall be considered by the agency. This solicitation will be issued full and open competition. The complete specification and/or other information required for this combined synopsis/solicitation is available at <http://heron.nrl.navy.mil/contracts/RFP/06cb03.htm> The provision at 52.212-1, Instructions to Offerors-Commercial, applies to this acquisition. The provision at FAR 52.212-2, Evaluation--Commercial Items is incorporated. The Government intends to award a contract resulting from this solicitation to that responsible offeror whose offer conforming to the solicitation will be the most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate the offers: (1) Technical capability of the system offered to meet NRL's needs (2) Price and (3) Past Performance. Technical and past performance when combined are of equal importance compared to price. Offeror must complete and submit with its proposal, FAR 52.212-3 Offeror Representations and Certifications--Commercial Items and DFARs 252.212-7000 Offeror Representations and Certifications--Commercial Items., which are identified as B and available electronically at : <http://heron.nrl.navy.mil/contracts/repandcerts.htm> The clause at FAR 52.212-4, Contract Terms and Conditions-Commercial Items and FAR 52.212-5, Contract Terms and Conditions Required To Implement Statutes or Executive Orders--Commercial Items, applies to this acquisition. The DFARs clause at 252.212-7001, Contract Terms and Conditions Required to Implement Statutes or Executive Orders Applicable to Defense Acquisitions of Commercial Items applies to this acquisition. Facsimile proposals are authorized and may be forwarded to the contract specialist point of contact provided below. All EIT supplies and services provided under any resultant contract must comply with the applicable accessibility standards issued by the Architectural and Transportation Barriers Compliance Board at 36 CFR part 1194 (see FAR Subpart 39.2). Electronic and information technology (EIT) is defined at FAR 2.101. Any resultant contract will be DO Rated under the Defense Priorities and Allocations System (DPAS). The Contract Specialist must receive any questions concerning the RFP no later than 10 business days before the response date of this solicitation. An original and 2 copies of the offeror proposal shall be received on or before the response date noted above, 4:00 P.M., local time at the NRL address above, Attn: Contracting Officer. The package should be marked with the solicitation number, due date and time. The U.S. Postal Service continues to irradiate letters, flats, Express and Priority Mail with stamps for postage and other packages with stamps for postage destined to government agencies in the ZIP Code ranges 202 through 205.
