Description

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in Federal Acquisition Regulations (FAR) Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; proposals are being requested and a written solicitation will not be issued. The solicitation, N00173-07-R-JK08, is issued as a Request for Proposal (RFP). The solicitation document and incorporated provisions and clauses are those in effect through FAC 2005-16 and DFARS Change Notice 20070327. The associated small business size standard is 500 employees. NRL has a requirement for: Versatile Laser Cutting system to provide drilling, grooving, scribing, thinning, and marking functions (CLIN 0001-one each), installation and training (CLIN 0002-one

each), a standard commercial warranty (CLIN 0003-one each), Option I- Z-axis control (CLIN 0004-one each), Option II-Rotary motion control (CLIN 0005-one each), Option III-Spare parts and critical components kit including replacement nozzles, high-wear and short-lifetime components (CLIN 0006-one lot), and Option IV-Extended warranty (CLIN 0007-one each). Delivery and acceptance is at NRL, Washington, D.C. 20375, FOB Destination. Delivery shall be no later than 90 days from date of award. The provision at 52.212-1, Instructions to Offerors-Commercial, applies to this acquisition.

The provision at FAR 52.212-2, Evaluation--Commercial Items is incorporated. The Government intends to award a contract resulting from this solicitation to that responsible offeror whose offer conforming to the solicitation will be the most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate the offers, which are listed in the order of importance: technical capabilities, demonstrated ability to meet acceptance criteria listed as number 12 in the specs, past performance and cost.

All EIT supplies and services provided under any resultant contract must comply with the applicable accessibility standards issued by the Architectural and Transportation Barriers Compliance Board at 36 CFR part 1194 (see FAR Subpart 39.2). Electronic and information technology (EIT) is defined at FAR 2.101.

Any resultant contract will be DO Rated under the Defense Priorities and Allocations System (DPAS). The Contract Specialist must receive any questions concerning the RFP no later than 10 business days before the response date of this solicitation. An original and 2 copies of the offerors proposal shall be received on or before the response date noted above, 4:00 P.M., local time at the NRL address above, Attn: Contracting Officer. The package should be marked with the solicitation number, due date and time.
